#### Rights, restrictions etc. of other classes of shares

Other Classes of shares – i.e. Voting, Income, Redemption, Repayment and distribution of any surplus on liquidation. These instructions require specially drafted articles to meet the circumstances of the case and attract additional charges over and above the standard cost of registration, the amount will depend on the time and complexity involved.

#### **COMPANY NAMES - PLEASE READ VERY CAREFULLY**

The Registrar of Companies will, with certain specified exceptions, register any name which is not indentical to one already on the Register. An existing company, if it finds that a company with a similar name has appeared on the Index, can complain to the Department of Trade who, within a year of the new name appearing, can order the new company to change it's name. Alternatively, as always has been the case, the existing company can apply for an injunction in the civil courts for an order that the new company change its name and stop trading under it.

Whether you are interested in changing the name of an existing company, in registering a new company under your own choice of name or acquiring a ready made company we will look at the Companies index for you and will draw attention to any other company which we find who in our view might complain. However, an inspection of the Index, no matter how carefully carried out, can never be totally reliable or satisfactory. The index is completely alphabetical, even including initials, numbers, abbreviations and forenames. The addition of any prefix to an otherwise identical name will usually place it in an entirely different part of the index; hundreds or thousands of names from the one being investigated. Furthermore, many names can be spelt in different ways although pronounced similarly such as Key or Quay or J.B. and Jaybee. It is impossible to think of every variation in the time available: not to mention the human element involved.

Problems can also arise when a name is registered which is similar to an unregistered Business Name or a Trade Mark. Regrettably there is no official register of Business Names. If you are concerned about Trade Marks you can ask us to carry out a personal search at the Trade Marks Registry itself, the cost of which varies with the time taken. The additional services do of course increase the cost, which is regrettable, but in view of the current legislation it is our duty to draw attention to it so that you can assess the risk and decide whether to use this service or not.

In consequence it must be agreed that we cannot be responsible for any trouble which might arise or any expense which might be incurred over any name we overlook, fail to find, or omit to mention howsoever caused. We feel sure that you will agree that it is reasonable for us to accept and carry out or work only on that basis.

PLEASE NOTE that it is not possible to reserve a Company Name (apart from Ready Made Companies that are already registered) and therefore it is inadvisable to incur any expenses in the advance printing of business stationery, signwriting etc. in the Company's Name. Any such expenses are incurred at your own risk.
